- The Pantheon Committee reserves the right to determine the eligibility of any project. Songs will be accepted only if they have not been played in Cyprus.
- All CD cases must be labeled with the title of the entry and contact information. Songs in progress will not be considered and cannot be played at the Pantheon.
- Submissions will be acknowledged upon receipt.
- All submitted materials become property of Pantheon Cultural Association and cannot be returned. By submitting this material you acknowledge Pantheon Cultural Association's right to copy any submitted material for Pantheon Cultural Association's non-commercial use only.
- A confirmation email will be sent upon receive of the application form and CD. Keep in mind that it can take a few days for us to reconcile your materials within our database, as we expect to receive a high volume of submissions for 2007. Some spam filters may filter out automated communications. Please add the following email addresses to your spam filter's list of approved senders to be sure our messages reach you: info@pantheongallery.org
- Entry CD Format: We accept songs mastered in any format, but projects must be submitted for consideration ONLY on wav or (high-quality) mp3 format.
- Attention! Length of song should be no more than 6 minutes.
- If you have two/or more songs and they're on one CD, you will have to send them as separate entries. Each song you submit must be accompanied by a separate entry form. One submission per CD.
- Any materials you send us will not be returned. Please do not send us your one and only CD copy.
- Incomplete applications will not be considered.
- The pantheon will not accept any responsibility for damage or loss of materials while in transit.
- There are no participation fees.
